



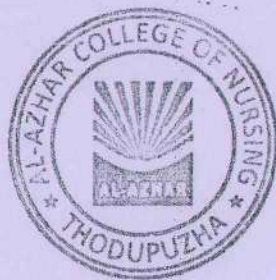

Al-Azhar College of Nursing, Thodupuzha is an Educational Institution established in the year 2022, Thodupuzha offers B.Sc. Nursing course affiliated to Kerala University of Health Sciences, Thrissur. The annual intake of students to B.Sc. Nursing course in the college is 50. The institution offers quality and value based professional education in the medical field. The college situates near Thodupuzha. The institution is attached to Al Azhar Medical College and Super Specialty Hospital Thodupuzha which is an institution under the same management.

This prospectus contains the general rules and information relating to selection and admission to B.Sc. Nursing course in Al-Azhar College of Nursing for the academic year 2024- 25.

The rules contained in this prospectus are subject to addition/deletion/ modification as maybe deemed necessary subject to orders of competent authority/court of law.

## DETAILS ABOUT THE INSTITUTION

### 1. Management :

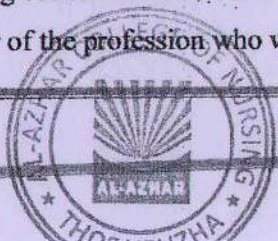

The main objective of the Trust is establishment and conduct of educational institutions, mainly professional educational institutions with a view to impart professional education in backward areas especially Idukki District.

### 2. Al Azhar Medical College and Super Specialty Hospital:

Al Azhar College of Nursing is attached to Al Azhar Medical College and Super Specialty Hospital run by Noorul Islam Trust. Al Azhar Medical College and Super Specialty Hospital was granted with permission from the National Medical Commission erstwhile Medical Council of India in the year 2014 to start MBBS course with 150 seats of intake capacity. The institution is a 740 bedded, tertiary hospital with highly experienced medical staff. The institution aspires to provide world class & affordable medical care for everyone. Al Azhar Medical College and Super Specialty Hospital is the parent hospital of Al Azhar College of Nursing. #### 4. General Objectives of the Course

On completion of BSc Nursing Program, the Nursing Graduate will be able to:

1. Utilize critical thinking to synthesize knowledge derived from physical, biological, behavioral sciences and humanities, in the practice of professional nursing and midwifery.
2. Practice professional nursing and midwifery competently and safely in diverse settings, utilizing caring, critical thinking and therapeutic nursing intervention with individuals, families, and communities at any developmental stages and with varied lived health experiences.
3. Provide promotive, preventive and restorative health services in line with national health policy and programs.
4. Integrate professional caring into practice decision that encompass values, ethical and moral and legal aspects of nursing.
5. Apply concept of leadership, autonomy and management to the practice of nursing and midwifery to enhance quality and safety in health care.
6. Utilize the latest knowledge and skills related to information and technology to enhance patient outcomes.
7. Communicate effectively with patients, peers and all health care providers.
8. Utilize the requisite knowledge, skills and technologies to practice independently and collaboratively with all health professionals.
9. Integrate research findings and nursing theory in decision-making and evidence-based practice.
10. Accept responsibility and accountability for the effectiveness of one's own nursing and midwifery practice and professional growth as a learner, clinician and leader.
11. Participate in the advancement of the profession to improve health care for the betterment of the global society.
12. Assume the role of practitioner, teacher, supervisor and manager in all health care settings.

#### 5. Eligibility for admission to BSc Nursing course:

a. **Nativity:** Only Indian Citizens are eligible for admission to B.Sc. Nursing notified as per this prospectus

##### b. **Academic Eligibility**

Candidates who have passed the Higher Secondary Examination conducted by the Board of Higher Secondary Education, Kerala or examination recognized equivalent thereto as approved by Kerala University of Health Sciences, with 50% marks in Physics, Chemistry, Biology separately and 50% on the total of Physics, Chemistry and Biology put together with pass mark for English are eligible for admission.

Vocational Higher Secondary Examination, Kerala has been recognized as equivalent to the Higher Secondary Examination Kerala.

**Eligibility Certificate:** - Candidates who have passed their qualified examination from outside the State of Kerala shall produce the certificate of recognition and equivalency of qualifying examination from the University/ Board of Higher Secondary Examination concerned of Kerala. This should be furnished at

the time of admission.

Academic eligibility should be satisfied as on the last date fixed for submission of application for admission. Candidates are advised to visit the website frequently on admission related matters

**6. Age:**

Minimum age for admission will be 17 years and upper age limit is 35 years. (both as on 31<sup>st</sup> December 2024).

**7. Duration of the Course:**

Duration of the BSc Nursing shall be 4 years.

**8. Syllabus:**

Syllabus of the course shall be the BSc Nursing Syllabus of the Indian Nursing Council and Kerala University of HealthSciences Thrissur (KUHS).

The total number of the seats to BSc Nursing Course in the institution is 50.

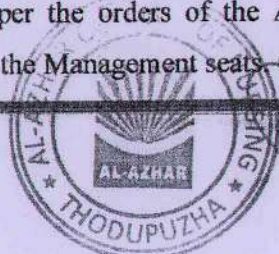
**Allotment of Seats**

**General Merit seats:** Government seats are those in which the Director of Medical Education through L B S makes allotments. Admission to these seats will be made based on the basis of merit. Admission process of allotment to Government merit seats (50%) will be done by the Director, LBS Centre for Science & Technology, under the supervision of the Director of Medical Education. Candidates are requested to visit the official website of LBS Centre for

Science and Technology Thiruvananthapuram [www.lbscentre.kerala.gov.in](http://www.lbscentre.kerala.gov.in), for details. **Management**

**seats:** These are the seats, other than Government General Merit seats (50%), against which the allotment will be made as per the orders of the Admission Supervisory Committee. There will not be any type of reservation in the Management seats. Candidate shall pay the Tuition fees and Special

fees, fixed by the Government. The eligibility for admission is same as for general merit and the candidate will be selected on merit. The admission to management seats will be based on Rank List prepared on the basis of merit.

#### 11. Preparation of Rank List

For allotment to B.Sc. Nursing, Rank List will be prepared on the basis of marks obtained for the qualifying examination by candidates for Physics, Chemistry and Biology put together.

#### 12. How to Apply:

Merit seats (50%) are filled up through the allotment process conducted by LBS Centre for Science and Technology Thiruvananthapuram. There will be separate application for Management seats (50%). The candidates applying for Management quota should apply through the application portal in the institution's website. The online application link will be published in the Website of the institution as well as in the notification published in the News Paper.


The print out of the application submitted through online, along with copies of certificates shall submit to the office of the institution directly or send to the office by Registered post with acknowledgment within the time limit notified for the same.

The application procedure will be as per the direction from the Admission Supervisory Committee for Medical Educations in Kerala and as per the provisions of the Prospectus issued by competent authorities in this regard.

#### 13. Documents to be submitted along with the Applications are:

- (a) Self-attested copies of Mark lists of all parts of Higher Secondary or equivalent qualifying examination.
- (b) Self-attested copy of the relevant page of S.S.L.C or Equivalent certificate to prove the date of birth.
- (c) Copy of Aadhaar of the candidate.
- (d) Equivalency certificate from Higher Secondary Board, Kerala, for candidates who have completed qualifying examination from outside Kerala state.
- (e) Copy of recent Conduct Certificate (not prior to six months) from the Head of the Institution in which the candidate studied last.
- (f) Copy of the Transfer Certificate from the institution where the candidate studied last.

**15. Admission**

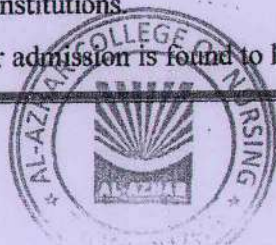
Candidates will be called for interview and for verification of Original Certificates and selected candidates will be admitted to the college on the dates notified for the same. Candidates should produce original certificates and documents for verification at the time of admission/interview.

**16. Anti - Ragging**

According to the Kerala Prohibition of Ragging Act, 1998, 'ragging' means doing of any act by disorderly conduct to a student of an educational institution, which causes or is likely to cause physical or psychological harm or raising apprehension or shame or embarrassment to student and includes teasing or abusing or playing practical jokes or causing hurt to such students or asking a student to do any act or to perform something which such students will not in the ordinary course be willing to do.

All institutions will have to abide by the directives of the Honorable Supreme Court of India. Dated May 16, 2007 in SLP No. (S) 24295 of 2006 University of Kerala Vs. Council Principal's Colleges, Kerala & Ors. (with SLP(C) No. 24296-99/2004 and WP (CrI.) No. 173/2006 & SLP (C) No.14356/2005] and the recommendations approved by the Honorable Supreme Court of India on effective prevention of ragging in educational institutions.

In case the applicant for admission is found to have indulged in ragging in the past or if it is noticed later

he/she shall be expelled from the educational institutions.

Each of the student of the institution and his/her parents or guardian are required to submit a combined, undertaking at the time of admission in the prescribed format as per **Annexure VII** of the Prospectus issued by The Director of Medical Education for admission to B.Sc. Nursing Courses which is mandatory for admission.

**17. Hostel**

Separate Hostel for Boys and Girls are available inside the college campus.

**18.** Students are liable to undergo BSc Nursing course and its syllabus as stipulated by Indian Nursing Council and Kerala University of Health Sciences (KUHS).

**19. Fee Structure:** The Fee Structure fixed by the Fee Regulatory Committee in its order dated 20.06.2022 and applicable to other Nursing Colleges in Kerala will be made provisionally applicable subject to final orders to be passed by the FRC.

**20. Refund of Fees:**


After closure of admissions, the seat if vacated cannot be filled up. Such seats will go vacant for the entire duration of the course. Therefore, those who leave the course after the closure of admissions will have to pay liquidated damages equivalent to the tuition fees for the remaining period of the course.

Those who leave the course before closure of admissions, the fees paid (after deducting administrative charges) will be refunded provided the Institution could fill up the vacancy.



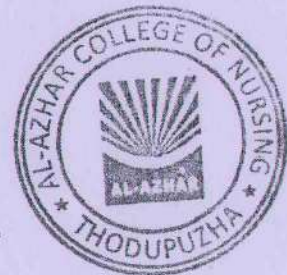
